**PETITION FOR REFERENDUM**

To the Honorable Breea Clark, Mayor, City of Norman:

We, the undersigned legal voters of the City of Norman, Oklahoma, respectfully order that the following proposed law shall be submitted to the legal voters of the City of Norman for their approval or rejection at the next regular general or special election as prescribed under authority provided the city in 11 O.S. 15-109.

The question we herewith submit to our fellow voters is:  
Shall the following ordinance be approved?

**NEW SECTION 8-112. - Restriction of Funds**

- (a) For the purpose of this section, "homeless shelter" shall mean a facility which provides temporary shelter, with daytime or overnight sleeping accommodations for homeless persons and which does not require occupants to sign leases or occupancy agreements.
- (b) The City of Norman may not expend tax dollars on homeless shelters without first referring the expenditure to a vote of the people.
